  - Festivals, Rodeos, & Concerts
  - Community Events (including seasonal activities)
  - Historic Sites, Museums, and Red Carpet Country Oklahoma Icons
  - Red Carpet Country Downtowns and Home Towns
- Photographs must be of events, activities, and places within the Red Carpet Country 16 county region. (Alfalfa, Beaver, Blaine, Cimarron, Dewey, Ellis, Garfield, Grant, Harper, Kay, Kingfisher, Noble, Major, Texas Woodward, and Woods)
- Include a brief description with photo: - Location of photo - Date taken - Event or attraction
- No more than 12 photographs per photographer.
